1. The meeting was called to order by Miller at 5:30 p.m.
Present were Marc Miller, Trustee; Paula Crook, Clerk; Chris Carlson, Treasurer; Township Residents; Township employees.
2. After a review of the minutes of the October 14, 2024 meeting, Miller asked if there was a motion to approve the minutes. A motion was made by Carlson with a second by Crook to approve the minutes. Miller, Crook and Carlson voted to approve the minutes. Motion carried 3-0.
3. **Township Auditing Board**
The beginning balance in the accounts is \$438,851.23. There were disbursements of \$134,456.25 and receipts of \$16,830.62 leaving an ending balance of \$321,225.60. The largest expenses of the month paid road contractors, payroll taxes, and the annual audit performed by Knudsen and Monroe. Carlson asked for a motion to approve the treasurer's report. There was a motion by Miller with a second by Crook. Miller, Crook and Carlson voted to approve the report. Motion carried 3-0,
4. **Board of Highway Commissioner / Road Overseer Report**
The mill and overlay of Crest Ridge is the only project left on the books for this year and no date has been set for it, yet. Carlson stated it may get pushed to 2025.
Other miscellaneous road repairs are being done now: gravel, grading of roads.
The evaluation of projects for 2025 has begun. Carlson stated that if there is a project residents would like evaluated for 2025, they should go to the website where they will be able to leave information about what they would like looked into.
Miller stated that John and Paul had repaired a street sign that had been run over in The Trees. Prepping for wintertime weather is taking place now.
5. **Old Business**
Carlson noted that last month Villas I attended the Township meeting questioning who had ownership of the wall that runs along 127th E to determine who was responsible for the insurance on the wall. Sedgwick County surveyed the wall area at the request of Minneha Township and it was determined that the wall lies 4 feet on Villas I property and therefore would be insured by Villas I.
Miller stated that the Township needs to make sure that the Villas I wall is not included on Minneha's insurance policy.



6. New Business

Carlson stated that the recent election has not been canvassed but has been counted 5-6 different times. Marc Miller was reelected as Trustee and Chris Carlson has been reelected as Treasurer. They each will be on the board through 2028.

- 7. Adjournment** – Miller asked for a motion to adjourn. A motion was made by Carlson with a second by Crook to adjourn the meeting at 5:36 p.m. Miller, Crook and Carlson approved the motion, 3-0.
