



**MINNEHA TOWNSHIP**

1. The meeting was called to order at 5:30 p.m.  
Present were Marc Miller, Trustee; Paula Crook, Clerk; Chris Carlson, Treasurer;  
Township Residents.
2. After a review of the minutes of the July 11, 2022 meeting, Miller asked if there was a motion to approve the minutes. A motion was made by Carlson with a second by Crook to approve the minutes. Miller, Crook and Carlson voted to approve the minutes. Motion carried 3-0.
3. **Township Auditing Board**  
The beginning balance in the accounts is \$545,225.84. There were receipts of \$64.85 and disbursements of \$115,899.58 leaving an ending balance of \$429,391.11. Carlson noted that the disbursements last month paid for a couple of road projects. The security fence at the Township property was a large expenditure last month. Carlson asked for a motion to approve the treasurer's report. Crook made a motion to approve with a second by Miller. Miller, Crook and Carlson voted to approve the report. Motion carried 3-0.
4. **Board of Highway Commissioner / Road Overseer Report**
  - A. The security fence at the Township maintenance facility was installed.
  - B. APAC has 3 or 4 more road projects to finish.
  - C. Andale is working to complete the sealing in Overbrook.
  - D. After closer examination, it was decided that the cracks on Pinnacle and Turnberry are too large for crack sealing. The roads will require a mill and overlay project. The project will be looked at further to see if that work would fall within the Township's budget.
  - E. Richfield Street, north of Bellaire, is heaving. Carlson has had the street looked at and expects estimates to see what it will cost to repair.
  - F. Carlson is still working on the easement in SSHID between the 2 properties north of Jack.
  - G. Looking at the possibility of turning Kinkaid into concrete. Carlson has contacted the City of Wichita because they have infrastructure funds. The road has deteriorated due to the new housing development that is city owned. Carlson is attempting to make the argument that the city should help Minneha concrete Kinkaid.
  - H. Carlson is getting pricing for a mill and overlay for The Meadows in 2023.
5. **Old Business** – There is no old business
6. **New Business** – There is no new business



7. **Adjournment** – Miller asked for a motion to adjourn the meeting. Carlson made a motion with a second by Crook to adjourn the meeting at 5:36 p.m. Miller, Crook and Carlson approved the motion, 3-0.
